Note

- CLSB will not be paying the sum of £2,747 (third and final tranche of LSB set up costs) payable on 31 March 2012 as these were agreed and signed to by the ACL under a Memorandum of Understanding with the LSB. The CLSB was not a party to that agreement.
- Whilst CLSB has revised its budget to include the per head levy (LSB & LeO) for Costs Lawyers on the register as at April 2011, it is the CLSB's position that as it only took over the role of regulator on 31 October 2011, it is for the ACL to pay that levy figure in full or 10/12ths of it.
