Legal Services Board 2015/16 Q1 Performance Report

Overview of the Quarter

- The programme highlight report at Appendix 1 provides a comprehensive overview of the Board's work to deliver its Business Plan during Q1 2015/16. The report is based upon the LSB's overarching programme and individual project plans.
- Attached at Appendix 2 is a quarterly report on Consumer Panel activity, and at Appendix 3 is an overview of our work in relation to requests for statutory decisions.
- 3. We have **removed** one Section 55 information requirement this quarter. The notice was issued in January 2013 to The Law Society regarding the Solicitor Regulation Authority's (SRA) alternative business structure (ABS) application process. This notice was revoked on 20 April 2015 as the SRA has now addressed many of the LSB's original concerns regarding its approach to ABS authorisation. In addition, the data the SRA has been providing has shown considerable improvement in the speed with which the SRA is dealing with ABS authorisation requests and we understand the SRA continues to review operational processes with the aim of delivering further improvements.
- 4. Based on an assessment of the status of individual projects, the LSB judges the status of its overarching programme to deliver its Business Plan for 2015/16 and thus its regulatory responsibilities is **Green.** This reflects that at this early stage of the business year we are largely on track to deliver our Business Plan milestones, however some re-scoping of continuing 2014/15 project level milestones and deliverables has been required, and the publication of some reports has been postponed until the end of Q2 to create a more even spread of LSB publications.
- 5. Matters of note not specifically addressed by the programme report include the following:

Organisation development and governance

6. This first quarter started dramatically with the fire on Kingsway meaning the LSB had to be evacuated from One Kemble Street. We were able to re-establish operations rapidly with the support of our third party IT provider with the result that all colleagues were able to work from home.

- 7. Three new colleagues have started with the LSB this quarter. Chris Nichols and Emma Kelly-Dempster have both joined as Regulatory Project Managers, and Stephen Brooker, previously the Consumer Panel Manager, has started his new role as Head of Research and Development.
- 8. There have also been significant changes in the Consumer Panel executive. Stephanie Chapman started as the Consumer Panel Associate in April and the position of Consumer Panel Manager has been offered to and accepted by Lola Bello who is due to start next quarter, in August.
- 9. We were delighted to hear that the Lord Chancellor and Lord Chief Justice agreed to extend the appointments of Bill Moyes and Ed Nally until 30 September 2015. This provides essential reinforcement for the Board in light of the failure to appoint a lay and non-lay member from recent recruitment rounds. The MoJ Public Appointments Team has commenced the competition to appoint a new lay member. Short listing will take place on 21 July. The non-lay competition has yet to commence but we are assured that this will be completed in time for an appointed to be made by 1 October 2015.
- 10. All new OLC Board Members have taken up their posts. Bernard Herdan, Michael Kaltz, Tony King, Jane McCall, and Caroline Coates all started their terms on 1 April 2015 and have attended two OLC Board meetings. We have stressed the need for appropriate induction arrangements to be put in place.
- 11. The LSB Audit and Risk Assurance Committee met in May. The agenda included the draft annual report of the ARAC 2014/15, the annual report on expenses, the Head of Internal Audit annual report and opinion, the NAO completion report 2014/15 and the draft LSB Annual Report and Accounts 2014/15. The ARAC also considered a paper on introducing inherent risk to the LSB's risks management process. The LSB's Annual Report and Accounts was laid in June with a clear set of accounts.
- 12. Constructive discussions took place with MoJ finance in June over the question of LSB FTLs. We are now preparing a small number of business cases to support requests for exemption or variation.

QASA judicial review

13. The Supreme Court ruled on the challenge to LSB's decision to approved changes to regulatory arrangements to implement QASA. The appeal by members of the criminal Bar was dismissed.

Relations with OLC

14. The Board have been updated regularly on developments at the OLC. This has included discussion on performance in light of Terry Babbs and Jenny Hart

meeting OLC and Legal Ombudsman colleagues in May to review KPI performance. Whilst discussion focused primarily on performance, the opportunity was also taken to reiterate to Michael Kaltz, the new lead OLC non-executive for this area, the purpose and importance of these meetings and to discuss updates around the review of LeO structures and Scheme Rules.

- 15. At the time of drafting, the OLC had just submitted its application for certification as an ADR entity. This follows constructive discussion with LeO colleagues on an earlier draft. The final application will be present it to the Board sub-committee with recommendations regarding approval. It is unlikely that certification will take place before 9 July, the original target date; however, due to the signposting requirements go-live date being pushed back until 1 October, some of the pressure to certify the Legal Ombudsman by 9 July has been removed.
- 16. The LSB used its power under section 121 of the Act to set performance targets relating to timeliness, unit cost and quality to act as 'trigger thresholds' in the sense that performance below these levels would trigger an obligations (under section 120 of the Act) on the OLC to explain to the LSB why performance had slipped to this level and what steps the OLC is taking to remedy the situation. The LSB has also used its powers under section 120 to require the OLC to provide a report to the LSB by 1 November 2015 that, amongst other things, sets out the OLC's proposals for a comprehensive framework for key performance indicators and performance measures to apply to the performance of the Legal Ombudsman scheme from April 2016 onwards. There is a requirement for an interim report on progress to be sent by 1 September.

Communications and stakeholder relations

- 17. The report on the first phase of the cost of regulation project was published before the start of purdah, as were the reports on online / DIY divorce, the Diversity Review and the three year strategic plan and 2015/16 business plan. Our research on online divorce was picked up by Radio 4 You and Yours programme.
- 18. Caroline Wallace took part in a panel discussion at the 360 Group annual conference.
- 19. The LSB twitter account now has 909 followers. This account proved useful in informing the general public of the difficulties the office faced in the days immediately after the Kingsway fire.
- 20. Our Chair spoke at the Georgetown University event on 24 April.
- 21. We are developing plans to fulfil the Board's commitment to hold a public event at some point this year. Our current thinking is the following:

- Hold the event on the day of the 26 November Board meeting from about 1630 to 1830, based on a similar format to the event held in Cardiff last year.
- Hold the event out of London, possibly Leeds, in partnership with the local Law Society, Bar Circuit and other key local stakeholders.
- Undertake the event in conjunction with Legal Services Consumer Panel and OLC, so we that can each explain our respective roles and priorities, and thereby make the event useful for as many potential attendees as possible.
- 22. We are in the process of organising two Board to Board engagements for later this year with the SRA and BSB. These build on the approach I discussed last month of keeping it small in number, informal and focused.
