

ACTIVITY REPORT: April – June 2015

Overview

During this period we have focused on the planning and delivery of our 2015-16 work programme.

We also published our annual report for work carried out in 2014-15. The Annual Report is an important document as it gives the Legal Services Board and our stakeholders, including legal services consumers, a record of our activities during the previous twelve months and allows them to hold us to account for this work. It is also a key means for us to demonstrate our impact and value for money. In order to reinforce the Panel's outcomes, the report reflects the five high level themes in the Panel's flagship publication, the Consumer Impact Report. This is the same format that was used last year.

The Panel met once in the period. In April, the Panel discussed the initial findings of the joint project with LSB on unbundled legal services, as well as agreeing a set of principles for how it engages with self-regulation initiatives. The Panel also discussed how it engages with stakeholders in the context of maximising the effect of the work to be carried out in 2015-16. The suggestions raised will be reflected over the coming months in the way we plan projects and meetings.

The Secretariat had two staff changes during this period. Stephanie Chapman, previously a Policy Adviser at the Financial Ombudsman Service, has now taken up the role of Panel Associate. Lola Bello, currently a Senior Associate at the Financial Conduct Authority, will be taking up the role of Panel Manager from 3 August 2015, as Steve Brooker moved on to the LSB on 1 May.
