<b>Summary:</b>
The Board receives regular reports about the key issues and risks concerning the implementation of alternative business structures ( <b>ABS</b> ). The July update is attached ( <b>Annex A</b> ).  The Parliamentary process around the affirmative Order is proving more controversial than expected by MoJ, given the limited scope of the Rehabilitation of Offenders (Exceptions) Order. We will update the Board about developments and implications at the meeting.
