Key Achievements in Q4 2011-12 Reporting Period

Regulatory Standards:

- 1. A plan for the internal intelligence gathering and the LSB self-assessment process has been devised.
- 2. We have briefed a number of regulators (BSB, SRA, IPReg) on the self assessment process and the final position on regulatory standards.
- 3. A piece of work sketching out the elements and processes an archetype legal services regulator might possess is being produced.
- 4. A template for intelligence gathering on each regulator has been distributed to colleagues for completion.
- 5. A number of discussions have taken place with regulators on the work.
- 6. A meeting with counsel was held to discuss the project and the use of the LSB's enforcement powers.

Disciplinary Processes and Appeal Mechanisms:

- 1. Reviewed project scope, proposals and PID and revisions were made PID which were discussed with the Gateway Group; further amendments awaiting approval.
- 2. Identified the characteristic principles of effective appeals arrangements based on the AJTC Principles for Administrative Justice.
- 3. Completed draft comparative analysis of the disciplinary appeals mechanisms of each regulator against the identified characteristic principles, including a gap analysis.
- 4. Began identifying the range of decisions made by regulators and where and which are/should be appealable.

Key Achievements in Q4 2011-12 Reporting Period

- Appointed TNS BNRB, Nigel Balmer, Pascoe Pleasance, and Richard Moorhead to undertake the High Street Research, jointly commissioned with The Law Society and Ministry of Justice. A draft survey has been cognitive tested and final questions agreed for the pilot. The pilot was started with 40 respondents to date
- 2. Completed two iterations of the Market Evaluation report, shared with RSG academics, LSB SMT, and nominated Board members for comment. This was then finalised and approved by the Board for publication 04 April 2012.
- 3. Finalised and published our business (IFF Research) and consumer studies (YouGov) looking at probate and estate administration.
- 4. Developed research plan for 2012/13, shared with Gateway Group, finalised and approved by the Board for publication on 04 April 2012
- 5. Received draft report on the consumer benchmarking research commissioned from BDRC Continental, and coordinated feedback from LSB and LSCP.
- 6. Interviewed three bids for development of Research website hub, appointed a company and held first meeting.
- 7. Developed and submitted outline conference papers for Socio-Legal Studies Association and Legal Services Research Centre research conferences in April and September respectively.
- 8. Received legal advice to support our work on cost protection from Hogan Lovells.
- 9. Supported small scale trade bodies' survey for small firms' use of legal services, and fedback on project materials.
- 10. Held business research reference group meeting, and reviewed and commented on draft report.
- 11. Completed research on consumers' demand for online legal support (Vanilla Research).
- 12. Received draft report on consumers' use of legal services (BDRC Continental).
- 13. Commissioned Dr Chris Hanretty to publish research paper on statistical modelling approach to assessing advocate quality.

Key Achievements in Q4 2011-12 Reporting Period

ABS:

- 1. Engagement with SRA on ABS licensing update.
- 2. Further discussions with SRA (and Law Society) on compensation fund and the s69 Order.
- 3. Meetings with IPReg and ICAEW on potential LA applications.
- 4. Joint SRA, MoJ, TLS, LSB meeting on penalty powers for SRA.
- 5. First ABS licences granted by the SRA to three applicants.
- 6. Legal advice received on the issue of SRA's ABS compensation fund.
- 7. Agreement was reached between the LSB and SRA that the sunset clause in the 2011 s69 Order that related to the ABS compensation fund should be removed. A consultation paper to publish the draft s69 Order (as required under s70 LSA) has now been drafted.
- 8. Engagement with SRA on ABS licensing update still a significant number of applications. However, it is clear that there are now some applications being finalised by the SRA. Contact will be maintained with the SRA to ensure that licensing can continue smoothly.
- 9. A further meeting was held with ICAEW to discuss technical aspects of its LA application including a discussion on the scope, plans and underlying constitution with regard to compensation fund powers. ICAEW have now provided us with a copy of its charter which will help assess this as well as add to the information about the independence and delegations in place.
- 10. Further analysis of BSB's proposals for LA application has been undertaken looking in particular at the proposals against the structure and requirements of the LSA.
- 11. The Gateway Group decided that as a project the ABS project had largely run its course, but noted that reporting should continue on significant unresolved issues, including:
 - the LSB as a direct licensor
 - the SRA compensation fund and sunset clause
 - the ending of transitional arrangements
 - ongoing ABS implementation.

Special Bodies:

- 1. The Board received an update paper on Special Bodies and agreement to proceed with development of consultation paper.
- 2. Meeting with MoJ to discuss approach and timetable. Some sequencing changes will need to be made to the timetable before we publish the consultation paper.
- 3. Meeting with Cabinet Office to discuss proposals and links to advice services review. Consultation paper developed and board agreement to proceed.
- 4. Further work on the timetable completed (to reflect sequencing agreed with MoJ) and programme milestones updated.

Key Activities for Q1 2012-13 Reporting Period

ABS:

- 1. Develop plans to monitor and resolve outstanding ABS issues.
- 2. A consultation under s70 of the LSA to cover a new (or revised) s69 Order to remove the sunset provisions from the 2011 s69 Order for the SRA's ABS compensation fund

Key Achievements in Q3 2011-12 Reporting Period

Diversity:

- 1. Action Plans received from SRA, CLC, BSB and ILEX. Draft plan received from IPREG and currently awaiting final plan. All but two plans were received by deadline of January 2012.
- 2. Assessment of plans now underway including discussion with regulators on issues such as data protection.
- 3. Reviewed Social Mobility Toolkit produced by Professions for Good (LSB is a co-funder). Final toolkit launched which received Ministerial support.
- 4. Meeting with BIS lead on Alan Milburn review to discuss progress with the review and provide an update on implementation of LSB transparency requirements.
- 5. Meeting with Cabinet Office lead on Social Mobility Business Compact to discuss LSB transparency requirements and opportunities for future joint working (eg breakfast seminars to highlight data publication).
- 6. Review of regulator action plans completed. Discussions have focused on entity publication and the reluctance of some of the regulators to require firm publication or responsibility on firms.
- 7. Meeting with SRA to discuss position on firm publication following submission of action plan.
- 8. Letters sent from Chris Kenny to regulator Chief Executives setting-out our initial views and highlighting the key areas of concern ahead of the formal Board discussion in April. Our intention is to publish the action plans along with our final assessment after the Board meeting but regulators should proceed with implementation in the meantime. We are yet to receive a final action plan from IPREG.

Quality Assurance:

- 1. Roundtable held on Voluntary Quality Schemes and exploration of development as a predictor / characteristic to prompt/reduce need for regulatory intervention.
- 2. Consultation paper on approaches to quality published in March.
- 3. Received various notes and reports from BSB and SRA on QASA levels, plea advocates, scheme amendments and local difficulties.
- 4. Series of high-level meetings between QASA CEOs, CPS and Thomas LJ to debate issues re plea advocates, amendments etc. LSB produced a note to describe expected actions and timings which appears to be gaining widespread consensus. Formal notice of SRA Board support received 010312. BSB press notice issued 020312 urging swift uptake.
- 5. Met with BSB on monitoring chambers initiative, and proposal for chambers to eventually become legal entities.
- 6. Met with LSC on quality assurance;

LSC in accord with LSB proposed approaches to quality.

7. Agreement reached between QASA CEOs, CPS & John Thomas on issue of non-trial advocates. JAG press release issued announcing decision and next steps: launch of the scheme in summer

2012 with start of notification period for all advocates (July 2012); consultation on the details of final proposals from June to September and judicial training starting in October 2012. Full launch is scheduled for January 2013 and will be introduced in three phases. JAG meetings have now restarted.

Education and Training:

- 1. Seminars launched with the first event at College of Law on 29 February. Good attendance (including Sir Mark Potter and Dame Janet Gaymer) and discussion/participation from the floor. Subsequent articles in Legal Futures and on Lawyer Watch.
- 2. Seminars held in Leeds and Westminster. Speakers agreed for Warwick event.
- 3. LSB 'think piece' on Legal Education and Training to accompany the series drafted and published. Paper will be sent to delegates for all events.
- 4. Update meeting with LETR executive (SRA/BSB/IPS).
- 5. Received update brief on LETR including summary of literature review.
- 6. Planning for Wales event on 10 May now underway.
- 7. Reviewed latest LETR discussion paper and summary literature review to input to LETR Consultation Steering Panel (attended by Chris Kenny on 13 March).
- 8. Update meeting with Julian Webb and Avrom Sherr from LETR team to discuss progress.
- 9. Meeting with Japanese delegation to discuss experience and issues around legal education and training.

Key Achievements in Q4 2011-12 Reporting Period

- Six presentations or speeches were delivered by LSB representatives including Chris Kenny and David Edmonds. Highlights included a presentation to the Joint Four Law Societies, a panel discussion at the European Law Students Association and a presentation to the Council for Mortgage Lenders.
- 2. In addition, we held three seminars, produced in collaboration with partner organisations across the country, designed to gather evidence for the reform of education and training.
