### Freedom of Information request

### Request:

- In particular, the information I am requesting is for the current pay ranges in operation at all levels of the Legal Services Board.

I write in response to your email of 2 November 2016 in which you request information about current pay ranges at all levels of the Legal Services Board. Your enquiry has been considered in accordance with the provisions of the Freedom of Information Act 2000.

I can confirm the LSB holds some of the information you have requested, and this is set out below.

- Senior leadership team fair pay disclosures were made in the LSB's <u>Annual Report</u> and <u>Accounts for 2015/16</u> at page 37 and 38 and state:

As at 31 March 2016 the Senior Leadership Team, excluding the Chief Executive, comprised seven senior civil service (SCS) equivalents – three men and four women:

SCS equivalent by pay band (based on full time equivalent salary rate)

Salary band	No. of SCS equivalent within band as at 31 March 2016
£60k - £70k	2
£70k - £80k	1
£80k - £90k	2
£90k - £100k	1
£100k - £110k	1

The salary of the LSB's Chief Executive is also contained within the LSB's <u>Annual Report and Accounts for 2015/16</u> at page 37 where the annual salary rate is noted as £140,000.

## Q2. In particular, the information I am requesting is for the current pay ranges in operation at all levels of the Legal Services Board.

The pay ranges in operation at all levels of the LSB are as follows:

Chief Executive – spot rate

Corporate Director/Strategy Director - £ £86,000 - £117,000

Director/Head of - £62,000 - £100,000

Manager - £45,500 - £65,000

Associate - £32,000 - £41,000

Support/admin staff - £23,300 - £30,000
