1. LSB and legal regulators

The LSB is a non-departmental public body that oversees the regulation of legal services in England and Wales. It is independent of both government and the legal profession. We hold to account the nine approved regulators for the different branches of the profession and the Office for Legal Complaints. The following are also approved regulators for probate activities only but do not currently authorise anyone to offer this service:

The following representative bodies are not part of the Legal Services Act 2007 designated approved regulators framework and therefore do not fall under our remit:

- the Notaries Society
- the Society of Scrivener Notaries and
- the Society of Licensed Conveyancers

2. Funding

A principle underlying the Legal Services Act is that the legal profession should pay for the LSB (and the Office for Legal Complaints (OLC), which is the body that provides the Legal Ombudsman service). Accordingly, the LSB is required to impose a levy on the approved regulators and that levy covers the full cost of running the LSB and OLC. Individual lawyers (e.g. solicitors, barristers, legal executives, patent and trade mark attorneys, costs lawyers and notaries) as well as firms or entities that are regulated by the approved regulators, must pay a practising fee to their approved regulator for the cost of regulation.

3. Other requests

Your other requests are for advice, and not for information that we hold. The LSB does not have a role to provide advice on interpretation and the LSB is not authorised to provide specific legal advice to members of the public or businesses on interpretations of the Legal Services Act.

If you are dissatisfied with this response to your request for information, you have the right to ask for an internal review / to submit a complaint (see <u>LSB's Freedom of information – Complaints procedure</u>).
